



(2011 - 2015)

When transformation isn't a buzzword, but a way of life



Gati's strategic moves explained

- **Joint Venture with KWE:** Gati partnered with Kintetsu Worldwide Express (KWE), forming a joint venture where KWE holds a 30% stake, providing operational synergies, global expertise, and strategic investment to enhance logistics and warehousing processes.
- Business Restructuring: The Andhra Pradesh High Court approved the amalgamation of several whollyowned subsidiaries into Gati Limited, effective 31st March 2013, allowing the company to create a Special Reserve of ₹5,555.43 Mn to offset capital losses and other future exceptional items, including a ₹640 Mn loss from the sale of Gati Ship Limited shares in 2012-13.
- **Divestment of Gati Coastal Shipping Division:** Gati moved its shipping assets to a subsidiary, Gati Ship Limited, sold 40% of its stake, and offloaded loss-making ships to reduce ongoing losses.
- **Business Transformation with IBM (Project Udaan):** Gati initiated Project Udaan with IBM, focusing on cost optimization and process improvements to enhance profitability.
- Gati Kausar, the cold chain arm of Gati Ltd, is raising ₹150 crore from Mandala Capital, with ₹30 crore in equity and CCPS and ₹120 crore in NCB, to enhance its cold chain services across sectors like healthcare, bio-pharma, and retail, making it one of India's largest refrigerated trucking networks.
- **E-commerce distribution division:** This vertical grew from 5 Cr. to 250 Cr. over a period of 3 years.
